

BE IT ENACTED by the House of Assembly of Kaduna State as follows:

- This Law is cited as the Revised Appropriation Law, 2020.

The Accountant General of Kaduna State of Nigeria, may on the warrant of the Commissioner of Finance, Kaduna State issue from the Consolidated Revenue Fund of Kaduna State during the year ending the Thirty First day of December, 2020 any sums not exceeding in whole the sum of Two Hundred and Twenty Three Billion, Six Hundred and One Million, Seven Hundred and Eighteen Thousand, Two Hundred and Forty Six Naira, Ninety One Kobo Only (№223,601,718,246.91) as specified in the schedule herein.
