WHAT IS A BUDGET?

A Budget is a plan. It shows what the Government is expecting as income (revenue) and what the government intends to spend the money on, which is called expenditure.

It is a document, which contains details on how the government plans to spend money. This money may be your personal share of Nigeria's wealth which the Government has collected on your behalf; e.g revenue, or your contribution which you pay as taxes to the government.

The Budget also contains other details; for instance, it will show whether the government intends to save or borrow money within the specified year. Local, State and the Federal Governments all have Budgets. The Budget document starts as a Bill at the Legislature, then metamorphoses into an Appropriation.

The Appropriation Act is the legal authority granted to the Government to spend your money on your behalf. This is done by the Legislature - the National Assembly or State Houses of Assembly - and in our case the Kaduna State House of Assembly (KSHoA).

When you vote for anyone in an election, you are simply giving the person the legal authority to approve and spend money on your behalf.

GRANTS

Grants are non-repayable funds or products disbursed or given by one party (grant makers), often a government department, corporation, foundation or trust, to a recipient, often (but not always) a nonprofit entity, educational institution, business or an individual.







Expenditure type as % of total 2021 budget





2021 Budget General Framework Billion Naira


















2021 Capital Project Allocation - Top 5 and Other Capital Projects





2021 Budgeted Expenditure




Expenditure type as % of total 2021 budget

MALAM NASIR EL-RUFAI GOVERNOR OF KADUNA STATE

AT THE PRESENTATION OF THE 2021 DRAFT ESTIMATES OF REVENUES AND EXPENDITURE TO THE KADUNA STATE HOUSE OF ASSEMBLY;

LUGARD HALL, KADUNA, ON TUESDAY, 6TH OCTOBER, 2020

PROTOCOLS The Deputy Governor, The Right Honourable Speaker, Principal Officers of the Kaduna State House of Assembly, Honourable Members of the Kaduna State House of Assembly, The Chairman, APC Kaduna State Chapter, Members of the Kaduna State Executive Council, Permanent Secretaries, Clerk of the House and Deputy Clerk of the House, Gentlemen of the Press, Ladies and Gentlemen.

- 1. I wish to begin by registering my profound appreciation to this Honourable House for granting us permission to present the 2021 Draft Estimates of Revenue and Expenditure of the Kaduna State Government. This is the sixth time we have been accorded this honour, and we present these budget estimates after subjecting them to public consultation through a Town-Hall meeting held on Saturday, 3rd October 2020. I note with gratitude the productive partnership between the Kaduna State House of Assembly and the Executive Branch in the service of our people.
- 2. Mr. Speaker, Right Honourable Members, permit me to recall the starting point of this governance journey and its goals. The Putting People First priorities of the Kaduna State Government were first outlined in the Restoration Programme, the Kaduna State specific iteration of the APC manifesto. We committed ourselves to develop human capital by investing in education, healthcare and social welfare; institute a good governance system that is founded on a competent and responsive public service; foster security; maintain, rebuild and expand Infrastructure (including water supply, electricity and road networks) to accelerate economic growth that will create jobs, jobs and more jobs; promote agriculture and food security and reform land administration as a basis for wealth creation and capital formation, while preserving and enhancing environmental management.
- 3. This government has since June 2015 used budgeting as a crucial tool in the process of signalling and in implementing change. We have enjoyed a strong partnership with this Honourable House in this quest. The close to 100 new laws enacted since 2015 include legislation to institutionalize reforms in public finances, procurement, taxation, child welfare and protection, investment promotion, scholarships, youth capacity building and residency, among others. The new laws also created a geographic information service and an internal revenue service.
- 4. With the sheer breadth of these initiatives, we expressed our commitment to promote equality of opportunity, accelerate human capital development, attain fiscal viability, and reduce inequality.
- 5. We have made significant strides over the past five years in delivering on our manifesto commitments. Through the Urban Renewal Programme, we are delivering the most significant investments ever in modernising infrastructure in our three major cities: Kaduna, Kafanchan and Zaria. The World Bank Ease of Doing Business Report for 2018 ranked Kaduna State as the Number One place for doing business in Nigeria, and the most improved in ease of doing business since 2014.

- 6. Kaduna State got the highest result among 24 eligible states in the 2018 performance assessment of the State's Fiscal Transparency, Accountability and Sustainability (SFTAS) Programme. We maintain strong partnerships with our development partners, including the World Bank in whose Performance for Result (P for R) and CARES programmes we are participating. The Islamic Development Bank and the Africa Development Bank have been veritable financing partners for the development of our state's water supply, education and health sectors. We are grateful for their support and confidence.
- 7. In 2019, Kaduna State entered the ranks of the top six states for internally generated revenue in Nigeria, collecting N44bn in taxes and levies without hiking tax rates. We have increased school enrolment, made education free and compulsory for all children till they complete senior secondary school and launched a multicampus system for all our state-owned tertiary institutions. We have began the construction of the KASU main campus in Igabi Local Government and reformed the scholarship system to reward merit and support the needy.
- 8. This government has completed the first two phases of the Zaria Water Programme, getting the water flowing into homes and offices after several decades, and began extending the distribution network to the other local government areas in the project design. We have signed a Memorandum of Understanding with the Federal Government for the Greater Kaduna Water Supply Project, which would rely on the construction of Itisi Dam to serve the present and future needs of our fast-growing capital city.
- 9. Mr. Speaker, Honourable Members, I will now outline some of the things that our APC government, with the full and bipartisan support of this Honourable House has accomplished in the service of our people in specific sectors:

a. Human Capital: Education

- 1. Expanding access to education through our free and compulsory basic education programme, saving parents about N3 billion per annum since 2016;
- 2. Implemented a primary school feeding programme, doubled primary school enrolment, and launched an extensive programme to renovate primary and secondary schools and supply them with furniture, water and sanitation facilities;
- 3. We recruited 25,000 new, qualified primary school teachers, to replace about 22,000 who failed the competency test. We also hired over 2,500 teachers of English, Mathematics, Science and ICT for our secondary schools;
- 4. Rehabilitated and upgraded physical facilities in our senior secondary schools, supplied classroom furniture to reduce the deficit and provided water and sanitation.
- 5. We increased the feeding allowance from N21 per day to N300 for every student in our boarding secondary schools;
- 6. Introduced the use of 15,000 electronic tablets for learning with lessons, examination questions and answers loaded for pilot preparation for the SSCE examination in our girls' secondary schools;
- 7. Strengthened SUBEB through new leadership to drive our agenda in basic education and bring more children to school in multi-storey classrooms to address congestion in our urban and rural primary and junior secondary schools across the state.
- 8. We revamped the scholarship system, increased allowances to those entitled based on either merit or need. We also introduced a low-interest loan scheme to cater for those not qualified for scholarship, but wishing to finance their tertiary education. Our Scholarship and Loans Board recently awarded 41merit-based scholarships for first class graduates to study abroad.
- 9. Identified a new main campus for the Kaduna State University in Igabi Local Government, and for satellite campuses in Makarfi, Lere, Birnin Gwari and Kauru. Along with TETFund and the CBN, we are supporting KASU to put facilities in place on the Main Campus.

ii. Health

- 1. Delivery of upgraded 255 Primary Health Centres, with maternal and ante-natal care equipment almost completed. Thousands of health care personnel have been recruited.
- 2. We are pursuing universal health coverage, through enrollment of citizens in the State Contributory Health Insurance Scheme;
- 3. Enhancement of health system resilience amidst the Covid-19 pandemic. New 136-bed Infectious Disease Hospital is almost completed. The Infectious Disease Control Centre in Kakuri has been upgraded, while extra facilities to expand treatment capacity have been opened in Kaduna, Kafanchan and Zaria. From zero molecular labs for COVID-19 testing in March 2020, the State now has three labs, one at the Yusuf Dantsoho Hospital, one at the ABU Teaching Hospital in Shika and the third in a private lab–DNA Labs, all capable of testing for Covid-19, tuberculosis, hepatitis, HIV and other diseases. The State also acquired 10,000 test cartridges being used by some of our GeneXpert machines to conduct Covid-19 and Tuberculosis tests concurrently.
- 4. Accelerated the rehabilitation and equipping of our general hospitals and comprehensive health centres. In collaboration with ABU Teaching Hospital, we brought the old Tudun Wada general hospital back into service for the benefit of the neighbouring communities;

iii. Social Welfare

- We initiated and funded several skills acquisition and entrepreneurship programmes for youths and women, including the Kaduna State Women Economic Empowerment Programme (KADSWEP) with N200 million low-interest microcredits targeting women entrepreneurs and vulnerable groups.
- 2. With Click-On Kaduna, thousands of young people are learning to code and acquire other digital skills at our Kaduna ICT hub;
- 3. We are encouraging graduate entrepreneurs through the Kaduna Start-up Entrepreneurship Programme (KADSTEP), giving them business training and facilitating funding of the bankable proposals they produce. A Centre for Women and Children is being built to provide shelter from sexual and gender-based violence, and equip our females with the skills and psycho-social support that can help them thrive;

b. Infrastructure

- We developed the long-term infrastructure master plan and a blueprint for the industrialisation of Kaduna State;
- ii. Launched the Urban Renewal Programme to improve infrastructure, transport connections and the live ability of our cities. It is a State Government intervention intended for our three main cities of Kaduna, Kafanchan and Zaria. The programme started with Kaduna, with new roads, expanded arterial roads, shopping malls and neighbourhood centres included. Contracts for the roads component of the Kafanchan and Zaria urban renewal programmes have been awarded, and will proceed in earnest at the end of the rains.
- iii. Completed the long-delayed phases 1 and 2 of the Zaria Water Expansion Project that now supplies potable water to Zaria and Sabon Gari Local Governments. Water transmission and distribution pipelines are now being extended to neighbouring local government councils starting with Soba and Giwa Local Governments;
- iv. We made other significant investments in infrastructure, especially roads to upgrade our urban centres and open up our rural areas. We recorded significant achievement in the construction of Rural Feeder Roads, including completing and successfully closing the Rural Access and Mobility Project (RAMP) funded by the World Bank. We have awarded 475.68km of township roads and 28 intercity roads with a distance of 531.47km.

c. Governance

- Curbing waste and fraud: We reduced ministries from 19 to 14 and continue to undertake periodic staff verification to enhance the integrity of the nominal roll and payroll of our workers and Pensioners;
- We made clear that we were committed to realizing progressive outcomes for our people and will
 not fritter resources on sterile populism. Accordingly, we stopped government sponsorship of
 religious pilgrimage;
- iii. Pension Reform: we passed a new Contributory Pension Law, which we implement faithfully as confirmed by the National Pension Commission. We also increased the minimum monthly pension to N30,000 for those on the old defined benefits scheme;
- iv. Reform of Land Administration: we abolished the Ministry of Lands, Survey and Country Planning in 2015. We replaced it with the Kaduna Geographic Information Service (KADGIS) whose mandate is land administration and the development and maintenance of a digital land registry.
- We launched the Public Service Reform and Revitalisation Programme that right-sized our state bureaucracy to an affordable structure and size and have recently enacted a new Public Service Law.
- vi. We have more than tripled internally generated revenue in the state N44bn in 2019 from what we inherited in 2015;
- vii. This government has recorded the highest levels of budget performance in the history of the State, injecting the largest ever capital investment in the history of the State. In 2019, Kaduna State achieved 97.5% budget performance for capital expenditure, spending N148.57bn of the N152.33bn budgeted. This is more than twice the erstwhile record of capital spending of over N62bn in 2016:
- viii. Implemented a raft of public financial management reforms, including entrenching zero-based budgeting systems and maintaining the Treasury Single Account (TSA), that consolidated about N25bn scattered in more than 470 bank accounts into one account at the Central Bank of Nigeria since 2016:
- ix. Reformed our local government system by restructuring and re- organizing it to solvency, enabling the Councils to not only pay series but also deliver real social services to citizens;
- x. We are the first sub-national government in Africa to deploy electronic voting machines, successfully using them for the local government elections in 2018 that were widely acknowledged for their fairness and credibility;
- xi. In the agricultural sector, we ended the annual ritual of fertiliser racketeering since 2016, making affordable, yet unsubsidized fertilizer available to farmers all year round, completed aggregation centres for farm produce in Giwa and Lere, and began the phased rehabilitation of irrigation schemes across the state;
- xii. In 2019, we introduced five policy councils to encourage government wide collaboration and eliminate silo mentality. Related ministries, departments and agencies are grouped together in the human capital development, economic development, infrastructure development, procurement monitoring and institutional development councils which meet on specific days of the week, as sub-committees of the Kaduna State Executive Council.

d. Investments

- The World Bank ranks Kaduna State as the number one place for ease of doing business in Nigeria from the 21st position out of 36 states and FCT in 2014;
- Kaduna State was Number One state as ranked by NIPC for attracting foreign direct investment, with \$800m already invested and \$2.1bn in pledged investments in 2020;
- iii. Five successful editions of the Kaduna Economic and Invest Summit (KADInvest) have helped showcase Kaduna State as favourite destination of job-creating foreign and domestic investments;
- iv. Through the \$150m Olam poultry and feedmill project, which was commissioned in 2017, we have made Kaduna the poultry hub of Northern Nigeria.
- v. We have broken ground for the N20bn Damau Milk Farm Project, collaboration between our State, the CBN and European dairy giant Arla. This is designed to help transform and modernise livestock production in Kaduna State into a commercially viable animal husbandry business;
- vi. Tomato Jos has not also multiplied per hectare productivity of our local farmers in Kangimi eight times, but has broken ground for the construction of their tomato processing plant. GB Foods is constructing a similar plant while Dangote Group has acquired Ikara Food Processing facility, along with 5,000 hectares of land for cultivating tomatoes and supporting local farmers as out-growers.

e. Security

- i. The foundation for all governance and development is human security. We have invested heavily to support federal security agencies in the state with vehicles, communications equipment and ordinance. Challenges remain with banditry, cattle rustling, kidnapping and armed robberies, as well as ethno-religious crises in communities in parts of the state. We remain engaged with the Federal Government on enhancing security. Through the Kaduna State Peace Commission, we are supporting community level peace-building initiatives like that currently underway in Zangon-Kataf chiefdom.
- ii. Investments in modern technology to assist security agencies, including the acquisition of RF trackers, unmanned aerial vehicles, CCTV installations and the forensic laboratory continue, and we hope to commission the first phase of our Kaduna Safe City project in 2021.

f. Housing

- i. We are expanding access to affordable housing through provision of single-digit interest rate mortgages in collaboration with Sterling Bank. The state has another tripartite arrangement with the Nigerian Mortgage Refinance Company (NMRC) and FHA Mortgages on affordable mortgage for our citizens. This is to make it easy for our people to buy and own their own homes in Kaduna State;
- ii. We have also commenced construction of affordable housing units in. various parts of Kaduna metropolis, for sale to the citizens of the state in 2021. With the mortgage facilities available, any citizen with predictable income can buy a home and pay over 10-15 years at single digit interest rate.
- 10. I have recounted some of our accomplishments compared to what we inherited in 2015, working together with this Honourable House. Let me refresh your memory, Mr. Speaker Sir.
- 11. In our first week in office back in June 2015, we were shocked and disheartened to learn that at least 50% of school pupils sat on floors because there was no adequate school furniture. We also learnt that many of these schools were overcrowded, dilapidated or completely lacking in water and sanitary facilities. In October 2015, we declared a state of emergency in the education sector to enable us to begin the huge task of making the 4,250 public primary schools and over 400 government secondary schools fit for our children.
- 12. The work has begun since 2015, and continues today and for the next few years. Bridging investment deficits of nearly two decades cannot be completed in five or eight years. We have started and hope to continue until we hand over to another administration in 2023, by God's grace.

The proposed 2021 Budget of Recovery

- 13. The uncertainties unleashed by the Covid-19 pandemic make it even more important to embrace fiscal realism. Therefore, the draft 2021 estimates are based on the following:
 - i. Limiting the size of the budget strictly in conformity with realizable revenues in the light of a post COVID-19 economy.
 - ii. Providing funds for projects from start to finish, while taking into cognizance ongoing projects and inherited capital liabilities.
 - iii. Maintaining the minimum budgeting baseline model of 60:40 ratio of capital to recurrent.
 - iv. Education and Health sectors holding a minimum of 26% and 15% of the total proposed budget respectively.
- 14. The government will strictly adhere to these targets, giving close attention to priority projects, strengthening expenditure control measures and seeking ways to significantly expand internally-generated revenue collection.

Summary of the 2021 Draft Revenue and Expenditure Estimates

- 15. In preparing the draft 2021 budget, we have taken into account the economic impact of Covid-19 and the continuing uncertainty it has unleashed. Despite the subsisting dangers from the pandemic, life must continue, and we must strive to manage the situation as best we can and make progress wherever possible. Therefore, we are proposing a 2021 budget size of N237.52bn, of which N157.56bn is capital and N79.96bn recurrent expenditure, a 66% to 34% capital to recurrent ratio.
- 16. As usual, the draft 2021 Budget prioritises capital spending and upholds our Putting People First governance agenda. It seeks to support our abiding commitment to Education, Health and Infrastructure by devoting 63% of the total budget to these sectors. The rationale for these choices is obvious. While Education and Health are the principal components of human capital development, investments in Infrastructure are critical to maintaining our competitiveness, supporting economic dynamism, creating jobs and promoting the well-being of our people.
- 17. In 2021, we propose to spend N59.59bn on Education (about 26% of the budget), N35.78bn or 15% on Health and N55.1bn or 23% on Infrastructure. A sum of N124bn, almost 79% of the capital budget of N157.56bn is allocated to the Economic and Social sectors. This preserves the ability to maintain investment levels in Education and Health, while continuing projects in the urban renewal programmes.
- 18. Mr. Speaker, Honourable Members, permit me to present the detailed summary of the recurrent and capital allocations, and to outline the proposed allocation to each sector:

19. Mr. Speaker, Honourable Members, we started out with a strong resolve in 2015 to reorient governance in this state, to put the real needs of ordinary people ahead of populism or short-term sentiments. We have steadfastly promoted equality of opportunity, delivering public goods for the many and making the investments to expand access to education and health care. We shall be taking steps to expand the enrollment of residents in our State into the database of the Kaduna Residents Registration Agency to enable us know who lives here and to better serve them.

Legislative Agenda for 2020/2021:20.

20. Mr. Speaker, Honourable Members, I have earlier paid tribute to this honourable House for the volume and quality of laws that have been enacted .We do not intend to present a Finance Bill for the 2021 fiscal year. This is because the COVID-19 pandemic makes it imperative not to raise any taxes or introduce new levies. Indeed, we may be approaching the Honourable House for further tax waivers to assist our businesses and households to be more liquid and better able to survive the negative impacts of the pandemic.

- 21. However, we shall be approaching the House with more bills to further strengthen governance in the State. The proposed bills will include:
 - a. The Kaduna State Executive Council recently approved the State Social Protection Policy. This places us in a better position to propose a Social Protection Bill to domesticate the various social intervention programmes of the Federal Government and propose a statewide social safety net that will address the basic needs of our poorest and most vulnerable citizens.
 - Chieftaincy and Traditional Councils Bill to entrench the reforms of the chieftaincy system, specify composition and classification of emirate and traditional councils, and update the provisions of colonial laws on the subject.
 - c. Employment Promotion Bill that will establish a State Council of Economic Advisers to guide the government on measures to promote job creation, economic development and investment promotion.
 - d. State Education Bill to re-enact our outdated education law, including updating the Universal Basic Education Law to repeal the 2005 law, and reflect lessons learnt in the implementation of the domestication of the UBE Act. This will enable the eventual elimination of the dysfunctional Out-of-School children phenomenon in Kaduna State.
 - e. Family Court and Small Claims Court (Establishment) Bills, along with legislation to amend the District Court Law, and
 - f. Another very important bill for the enactment of a State Commercial Code to guide the conduct of commercial activities, encourage innovation and investment in our State.
- 22. Mr. Speaker, Honourable Members, it is my pleasure to now lay before this Honourable House the draft estimates of revenues and expenditure for the 2021 fiscal year, and the Appropriation Bill accompanying these, for your kind consideration.
